O-I is looking to incorporate a batch and cullet preheater system into our process, for our Zanesville, OH plant. Scope of Work.

The overview of this scope will be looking to design, spec, and install the B&CPH system that has the capability of heating the batch up to 200 degrees Celsius. This will include the heat exchanger, the preheater, all ancillary equipment, a complete functional specification, and controls integration with owner's furnace system. Other considerations include Factory Acceptance Testing, including time for owner to review system and provide maintenance training, and on-site startup and assistance (including on-site training).
